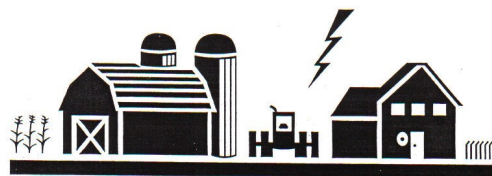

### ATTENTION: DEFERRAL OF INTEREST CHARGES

RMA approved a one-time deferral of interest charges for Spring Crops only. This is in effect until NOVEMBER 30TH. If any applicable premium remains unpaid by 11/30/20, it will be billed accordingly. You can view the official deferral bulletin on your premium billing statement.

If you do estimate, or plant a partial field, draw to show the area planted AND write down your estimated acres.



### PLEASE CONSIDER

When tenants have power of attorney (POA) to sign loss documents for their landlords—landlords get paid MUCH faster. It is a great convenience for landlords to have tenants sign loss documents as well as acreage and production reports. *However, this should not replace communication between tenant and landlord.* Landlords...if your tenant has POA at FSA for you, request FSA to fax our office a copy at 479-5505 or contact us for a form.

### WHEAT FINAL PLANTING DATE

Most Counties in our insured area - Oct 31...Late planting until Nov 15 w/ exceptions

County	Final Plate Date	Late Planting Period (LPP)
Lane	Oct 20	Oct 21- Nov 5
Kiowa & Pratt	Nov 5	Nov 6 – Nov 21
Marion & Morris	Nov 5	Nov 6 – Nov 21
Wabaunsee	Nov 15	Nov 16 – Dec 1

Acres planted during the LPP are to be insured w/ 1% APH reduction per day.



*Tenant Acreage reports due back by November 30th*  
*Production reports also due back by November 30th*

### CALL FOR AN APPRAISAL

**\*\*ENTERPRISE UNIT REMINDER\*\***

This must be selected or opted out of by September 30th for Wheat and March 15th for Spring Crops.

- ◆ 20 ACRES OR 20% OF YOUR TOTAL ACRES  
Must be on a second or more sections

Examples:

50 acres planted on section 1 + 10 acres on section 2  
DOES NOT QUALIFY: 60 total acres (20% = 12 acres)

50 acres planted on section 1 + 15 acres planted on section 2  
DOES QUALIFY: 65 total acres (20% = 13 acres)

**Co-mingling Grain...**

**Don't:** Add current year grain to prior years grain

**Don't:** Load truck with grain from 2 units without talking to us about approval

**Don't:** Put grain from 2 different units in the same bin without adjuster approval

**Don't:** Put grain from 2 different counties together in same bin

**Do:** Keep load ledgers, weigh loads, mark bins, etc.

**ATTENTION:**

**RMA RULES PLEASE READ!**

- \* If you CO-MINGLE grain from two units, tell us upfront at production reporting time. RMA will allow us to pro-rate the production between TWO UNITS. This **must** be identified on the production report.
- \* If you can not prove your reported yields in an AUDIT you will be given an ASSIGNED YIELD on EVERY UNIT that the CROP WAS PLANTED ON.

**NOW AVAILABLE**

**ONLINE PAYMENTS** - RCIS policyholders can now make Crop Insurance payments online. Payments post in 2 days. Visit RCIS.com, click "Make a Payment" under For Producers and it will step you through the process.

**DOC-U-SIGN** - New way to sign your claim work. Your adjuster will email you an online sign up form. Once signed up, you will receive an email notification that claim documents are ready to review. Click "Review Documents" and it will step you through the claim documents and direct you to sign at the end.

**PRF—Pasture, Rangeland, Forage**

- Choose to insure only acres important to your grazing program or hay operation
- Allocate a % of Value of your total insured acres—your total risk—for a given type, grid and share into 2 or more 3 month periods called Index Intervals
- You may elect to insure graze land or hay land
- Choose coverage levels of 70-90
- Select Productivity Factor between 60 - 150 % of the County Base Value
- Based on a 12 x 12 grid map and rain fall index
- **SALES CLOSING DATE NOVEMBER 15TH: Deadline to sign up/ cancel/ make changes**
